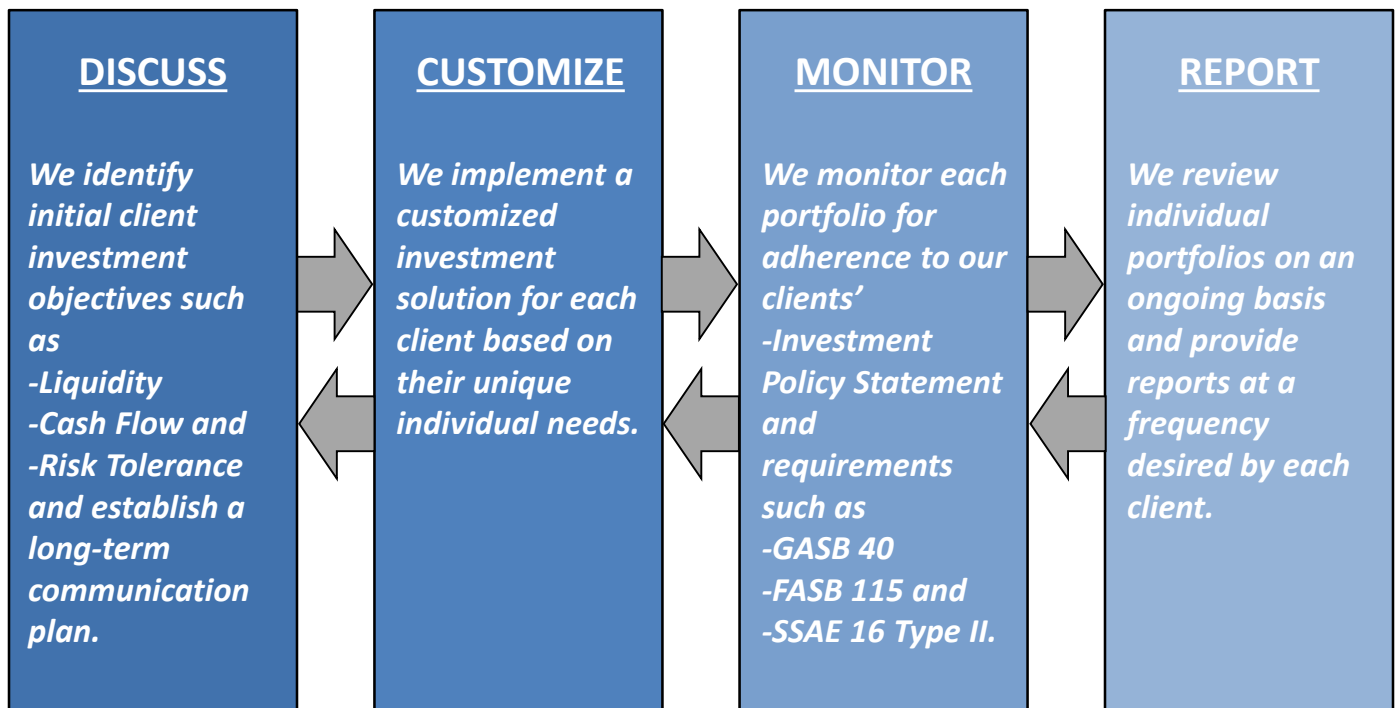

INVESTMENT STRATEGY PHILOSOPHY and PROCESS

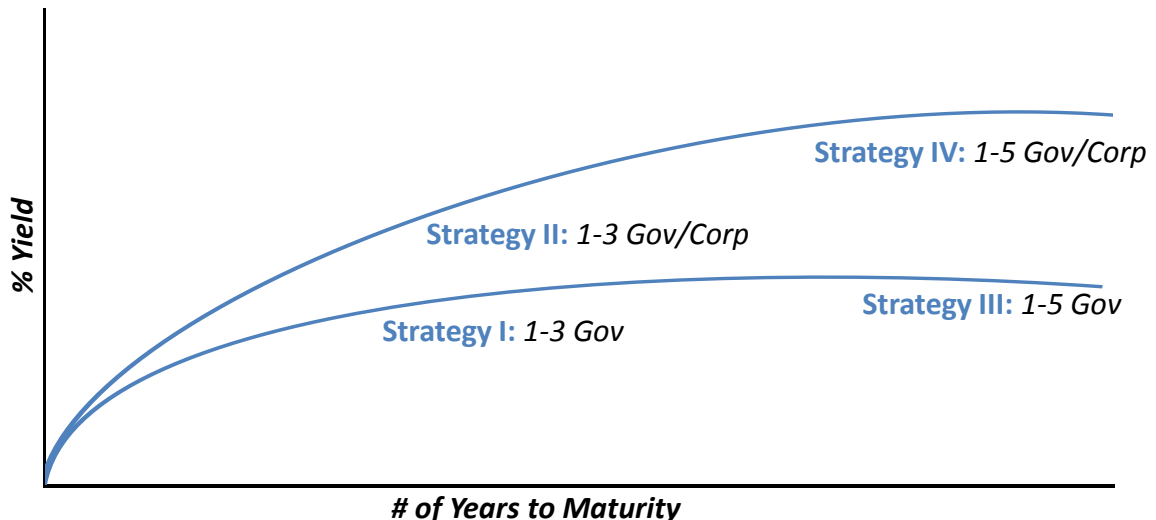
