



Information Specific to the Sawgrass Large Cap Quality Growth Equity Product: As of 12/31/2024, this composite was comprised of 48 accounts valued at \$650.4 million. Assets in this product represent 29% of the firm's total assets under management. Total product model assets under advisement are \$951.9 million and total firm advisory model assets are \$952.7 million. The three-year standard deviation for this product and its benchmark was 15.7% and 20.6%, respectively. This composite's creation date was 3/31/1998, and the composite's minimum account size is currently \$1 million. Net of fee performance includes performance based fees.

The investment management fee schedule is available in our Form ADV Part 2A as follows: 0.70% on the first \$10 million, 0.60% on the next \$20 million and 0.50% on the balance.

Composite Description: Accounts included are comprised of all actively managed equity accounts with assets greater than \$1,000,000 that are managed with a mandate of Large Capitalization Growth benchmarked to the Russell 1000 Growth Index. These accounts primarily invest in large capitalization U.S. growth equities. Prior to October 31, 2024, this portfolio was known as the Diversified Large Growth Equity Composite.
